Judge Amanda Hopkins made a motion to approve the final minutes of October 14, 2022, Ms. Petersen seconded the motion. The motion passed unanimously, minus Dr. Steffey who later joined the meeting.

Motion 1

Judge Hopkins made a motion that Chair Roan shall draft the response letter with the discussed amendments and will share the draft with the Board prior to its distribution. Dr. Steffey seconded the motion. The motion passed unanimously. Chair Roan stated she will with work with Assistant Attorney General Janna Fisher to send the response letter.

Motion 2

Chair Roan called for a motion to approve the final, amended draft of Ombudsman Villafuerte's FY 2021-22 performance evaluation. Judge Hopkins made a motion to approve the amended draft of Ombudsman Villafuerte's FY 2021-22 performance evaluation. Dr. Steffey seconded the motion. The motion passed unanimously minus.

BOARD BUSINESS

CPO Human Resources Employee Assistance Manager Position

Chain Roan wanted to know more information about the CPO's contract Employee Support Services Manager Tony Marusic, and his role with the agency. Ombudsman Villafuerte reported that Mr. Marusic's first day was November 1, 2022. He was hired as a contract employee. That contract will run through June 30, 2022. She stated the CPO's Fiscal Year 2023-24 Agency Summary and Budget Request will seek to make this contract position a full-time, permanent position at the agency.

Ombudsman Villafuerte reported that Mr. Marusic responsibilities including assisting in the development and implementation of a strong human resources program. In addition to providing employees services and supports, the position will also address employee recruitment, retention and performance management. The position will create an in-house resource for CPO employees to address their needs safely and confidentially.
