### **Board Member Appointment Updates**

#### Farewell

Ombudsman Villafuerte reported that, at the end of this month, the terms of several board members will concluded. Judge Ken Plotz joined the meeting at 8:09 a.m.

#### **New Appointment**

Ombudsman Villafuerte stated that she is pleased to announce the Chief Justice appointment of Hon. Gail Meinster who is replacing Judge Plotz. She brings a wealth of experience and expertise to the team. Her first term will expire on July 31, 2027.

#### Reappointment

Ombudsman Villafuerte reported that Brian Bernhard has been reappointed to the Board by the House Minority Leader. His second term will expire on August 1, 2027.

Ombudsman Villafuerte reported that the agency still has two appointments to fill, and that we are awaiting confirmation on the reappointment of April Lane by the Governor's office, whose term is set to conclude on August 1, 2023.

AAG Fischer read a statement from Ben Rounsborg to be considered for the Board chair position although he was not present at the meeting.

#### **Board Chair and Vice-Chair Elections**

Ms. Buxton-Andrade made a motion to nominate Ben Rounsborg as Board chair. Chair Roan seconded the

motion. The motion passed unanimously.

Chair Roan made a motion to nominate Judith Martinez as Board vice-chair. Ms. Buxton-Andrade seconded the motion. The motion passed unanimously.

AAG Fischer stated that the Board has appointed a new chair, Ben Rounsborg and vice-chair, Judith Martinez. Their term will end on July 31, 2025.

#### **CLOSING REMARKS**

Chair Roan closed by thanking members for their time and commitment to helping Colorado's most vulnerable children. She expressed her gratitude to serve as chair on the Board. Chair Roan thanked everyone for their collective efforts, expertise and collaboration that has enriched the Boards discussions and decisions.
